It is important that your grant is used effectively and based on school need. The <u>Education Inspection Framework</u> makes clear there will be a focus on 'whether leaders and those responsible for governors all understand their respective roles and perform these in a way that enhances the effectiveness of the school'.

Under the **Quality of Education** Ofsted inspectors consider:

Intent - Curriculum design, coverage and appropriateness

Implementation - Curriculum delivery, Teaching (pedagogy) and Assessment

**Impact** - Attainment and progress



On a rotation, the equipment was set out at break times and lunch times to encourage the pupils to use the equipment and work/play collaboratively.		The equipment is used every break and lunch time so the pupils are getting more than 30 minutes of physical activity a day. The pupils have learnt new skills as some pupils are now able to skip, know how to hold a tennis bat to control the ball and how to use a hula hoop and increase the time they use the equipment.
