All PP pupils are referred us having been either permanently or on fixed term exclusions for issues relating to challenging behaviour. This has had a detrimental impact on progress.

The reading ages of PP pupils entering the service are lower than their chronological ages, this hinders access to all areas of the curriculum and life chances.

Attendance on entry is poor compared to national averages. This affects progress.
